Last week 198 investments were filed with the SEC, 30 more deals than the previous week. 85% of the private placements curated by XDATA weren't disclosed via press releases. Some were substantial \$160M NantHealth, \$24M Berry Aviation or the \$9M raised by IoT ring developer Nod. Samples of the deals you may have missed are available on page 3.

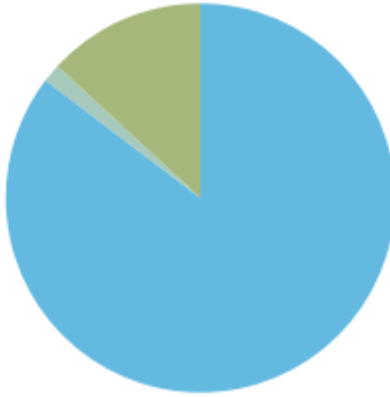

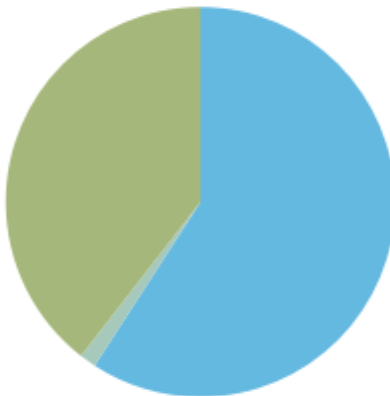

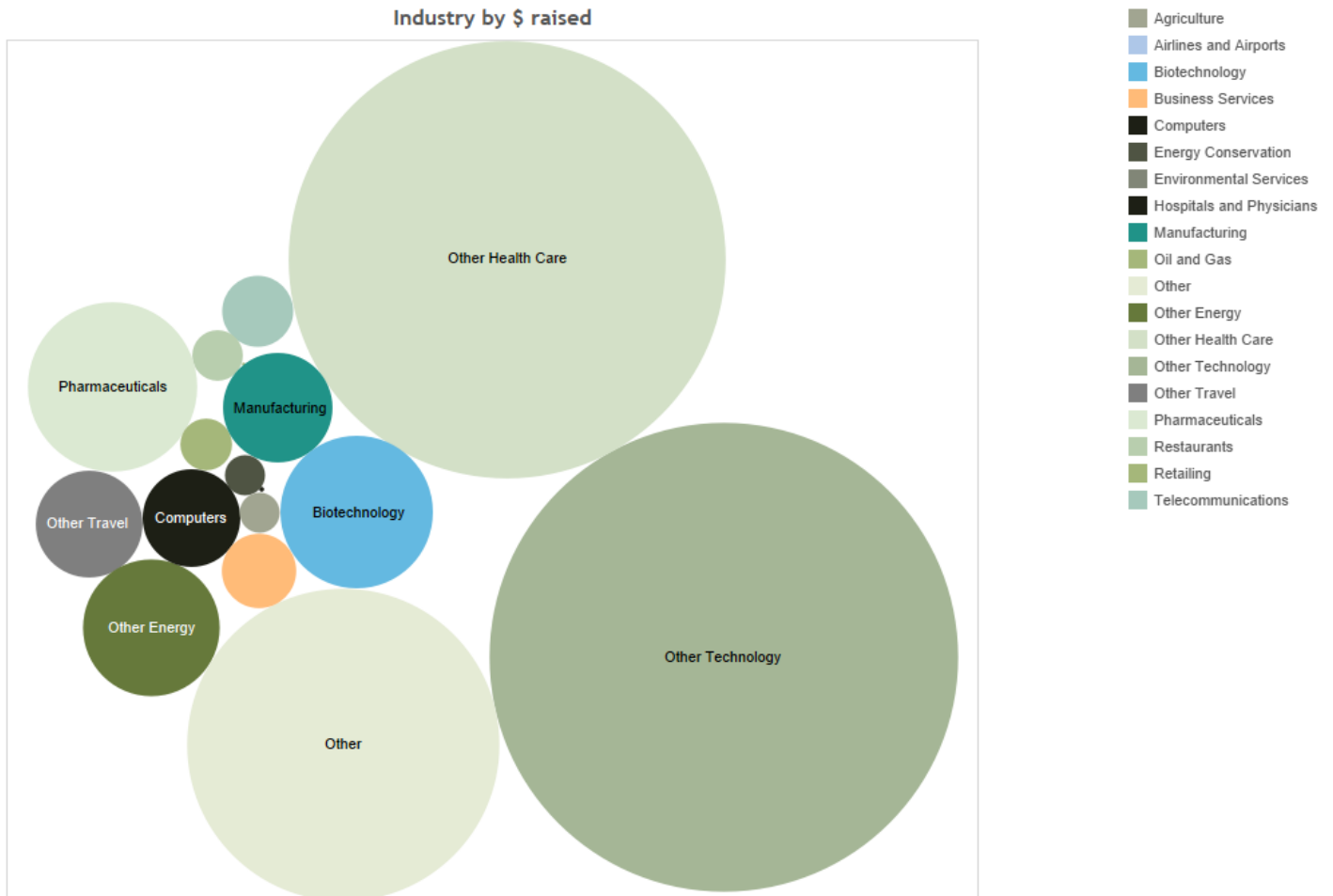
